NHS England is the independent organisation now responsible for managing the budget and the day to day workings of the NHS. It supports clinical commissioning groups to improve patient care. To make sure the taxpayer has a say in how this money is spent, the government provides direction and ambitions for the NHS through 'the Mandate'. By March 2015, the Government expects NHS England to make improvements in the quality of care it offers. They should: 1. help people live well for longer; 2. manage ongoing physical and mental health conditions; 3. help people to recover from episodes of ill health or following injury; 4. make sure people experience better care; 5. provide safe care; 6. free the NHS to innovate; 7. support the NHS to play a broader role in society; and 8. make better use of resources.

The need for the NHS to achieve four per cent year-on-year efficiency gains has been the dominant issue for the Health Committee throughout the Parliament as it has looked at expenditure issues. This report indicates that the straightforward savings have been achieved, but that little progress has been made on transformative change. The conclusions of the report include: the NHS has provided savings during the first two years of the programme, but that there is a question mark about how sustainable they are; the straightforward savings which are possible have now been made; and the transformation of care that will be required to make the NHS sustainable in the future and able to deal with increasing demand has yet to take place. The key question raised in the evidence asks what the money saved has been spent on; the answer is not transparent, and more needs to be done to demonstrate what new activity has been achieved due of the gains of the efficiency process.
